- Fill all the details and proceed to pay instantly. On re-direction to Remita gateway, you can either pay online or take the generated Remita Retrieval Reference (RRR) code to any commercial bank to pay. You have the option to register either as a physical attendee or a virtual attendee. It's important to understand that physical attendees will gain access to the event venue and all associated physical materials, whereas virtual attendees will only have access to electronic proceedings and certificates.
- The following happens on successful payment:
